## Public Works Committee of the Village of Lena Thursday, March 31, 2016, 2:45 p.m. Lena Municipal Building, 117 E. Main Street, Lena, WI

Call to order – Meeting called to order at 3 p.m.

Roll call: Steve Marquardt, Craig LeFebre and Linda Hinds.

<u>Also present:</u> Doug Bergeson, Larry Shallow, Robert Gmirek, Craig Schuh and Steve Reusser- Ayres Associates.

Agenda – Motion to approve the agenda was made by Marquardt. LeFebre seconds the motion. Motion carried.

<u>Minutes</u> – Motion was made by Marquardt to approve the minutes from March 8, 2016. LeFebre seconds the motion. Motion carried.

Open Forum – Robert Gmirek expressed concerns regarding the lawn that was damaged by the snowplow at 527 Cedar Street. Also the patch on Cedar Street is breaking apart. Utility workers will repair the lawn as weather allows. Utility workers training at Rural Water was reviewed. Lead in the water was a hot topic at the conference. Job description for summer help is needed. A class from the high school visited the water treatment and sewer plants. New recycling building needs to be delivered. Location/placement needs to be decided. Old building is to be sold to the highest bid.

<u>Garland street lights/LED vs regular</u> – After reviewing the cost quotes it was decided to order LED lights as they last longer.

<u>Harley Street Water Flow – Cory Ama – Trustee Craig LeFebre will talked with the property owner regarding the blocked pipe.</u> The committee will do a walk through after today's meeting.

<u>Sewer Plant Operation and Needs study</u> - Craig Schuh and Steve Reusser-Ayres Associates presented the operation and needs study for the sewer plant. Discussion followed regarding what is needed/improvements. Available grants and payment plans were discussed. WI DNR permit is being published with a 30 day comment period. A brief summary will be presented to the Village Board.
