<u>Water Treatment Project updates</u> – Ayres Associates Engineer Sarah Nunn updated the board on the progress of the construction. Change order – none. Pay requests – Terry Hinds made the motion to approve pay request for WI DNR \$310,646.68 Jossart Brothers. Larry Belongia seconds the motion. Fire Extinguishers for the new water treatment building proposal were \$707.60. Village will order. Generators are diesel and need to be run monthly. <u>Saputo Waste water treatment project</u> – nothing new to report. Long term lease agreement - The Village owned water treatment building can be sold per Mark Williams at the State. Motion was made by Terry Hinds to pursue the sale of the waste water treatment plant used by Saputo USA. Judy P. seconds the motion. Motion carried.

<u>Storm Sewer – Fire Station</u> – Sarah Nunn reported on the 2 options for repair and the approximate costs. A price quote from Duame Sand and Gravel will be requested.

<u>GIS Proposal – 22 acres subdivision plat proposal</u> – Motion by Chad Misco to approve the Ayres Associates contract for GIS System for a cost of \$12,475.00 and also including \$1350 ArcView license and \$400 ESRI ArcView renewal. Larry Belongia seconds the motion. Motion carried.

New Business:

<u>Snow plow/Utility Vehicle</u> – Quotes were reviewed. Motion by Craig LeFebre to purchase a plow blade from Olson's for a cost of \$16,849.00. Terry Hinds seconds the motion. Motion carried. Utility truck with boxes – two quotes were reviewed. Public Works was instructed to develop specification needed.

Sludge Removal process pricing – Options and costs were reviewed. Quote for \$130 per hour plus fuel.
