Hinds made the motion to take \$10,000 street improvement CD to help pay street improvement bills. Marquardt second the motion. Motion carried.

<u>Ayres Associates</u> – Troy Robillard-Manager and Craig Schuh-Engineer from Ayres Associates were present to discuss the status of the Village engineering. Comparative costs were discussed. Engineer at board meetings was reviewed. C. Schuh will send a cost estimate used for the ITF/PERF to the Clerk for the sewer/water updates on Maple Street, Sanitary Sewer behind Patenaude's and updates to sewer plant.

Financials – Hinds reviewed.

<u>Rescue Squad Contract – Oconto Falls Ambulance Service</u> – waiting for updated contract.

<u>Sewer Rate Increase</u> – Discussion followed and history was reviewed. Motion was made by Marquardt to recommend the village board adjust the base rates by 10% and increase the volume charge to \$4.60 per 1000 gallons. Hinds second the motion. Motion carried.

<u>Resolution 2016-15 Village 2017 Budget</u> – Motion by Hinds to present to the Village Board to adopt the 2017 budget. Linzmeyer second the motion. Motion carried. <u>Special assessments/charges</u> – Village clerk reviewed the assessments/charges that will be added to the tax roll.
