We are pleased to present our Annual Water Quality Report for 2013. This report is designed to inform you about the quality of the water and services we deliver to you each day. Our goal is to continue to provide a safe and dependable drinking water supply to our customers. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. We currently draw our water from two deep sandstone wells that are constructed in the Elk Mound Group of the Cambrian Aquifer.

- Well #1 is located within the Village Hall at 117 E. Main St.
- Well #2 is located at 439 Harley St

The Village of Lena routinely monitors for constituents in your drinking water according to State and Federal Laws. The following tables show the results of our monitoring for the period of January 1st, 2013 through December 31st, 2013.

Health Information

Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally- occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Contaminant Health Effects

RADIUM, (226 + 228) Some people who drink water containing radium 226 or 228 in excess of the MCL over many years may have an increased risk of getting cancer.

Additional Health Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Lena Waterworks is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using

water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Corrective Actions Taken

Radium (226/228): Well #1 located at 117 E. Main St exceeded the MCL and the well was temporarily removed from service on Feb. 25, 2013. The well will remain out of service until the new HMO Treatment facility is completed. Construction of the facility is to begin in 2014 and scheduled to be completed in 2015.

Information on Monitoring for Cryptosporidium and Radon

Our water system did not monitor our water for cryptosporidium or radon during 2013. We are not required by State or Federal drinking water regulations to do so.
