<u>Closed session for consideration of comp time policy.</u> Per WI State Stats 19.85 (c) for the purpose of considering employment, promotion, compensation or performance evaluation of any public employee over which the governmental body has jurisdiction or exercises responsibility. Motion by Linzmeyer to convene to closed session and allow Linda Hinds to be present. LeFebre second the motion. Roll call vote: Linzmeyer aye, LeFebre aye, T. Hinds aye. Motion carried.

<u>Return to Open Session</u> – Per WI State Stat 19.85 (2) and possible action from items discussed in closed session - Motion by Linzmeyer to reconvene to open session per State Stats. LeFebre seconds the motion. Motion carried at 3:30 p.m. Motion by T. Hinds to proposed to the Village Board that employees will have the option for comp time to be paid out at the time earned or accumulate up to 40 hrs. until October 31st. Any accrued comp at that time will be paid out at the next pay period. No carry over will be allowed to the next year. Linzmeyer second the motion. Motion carried.
