Motion was made by Marquardt/LeFebre to recommend to the Village Board they approve the Construction Administration and Inspection Services Sewer Relining Project from Ayres Associates not to exceed \$24,500 and hours would be adjusted if it comes in less. Motion carried.

Review & Recommendations Preliminary Compliance Alternatives Plan Agreement – Ayres Associates: Cost is not to exceed \$21,400. Motion was made by Hinds/Marquardt to recommend to the Village Board for approval. Motion was voted and carried.
