Welcome to Summer! Based on the heat blast we have had, it could be a hot summer!

In this newsletter, I would like to talk about village ordinances, their purpose and why they are important. Ordinances are created and adopted to serve as the guidance on how our village operates and enforces local codes. Our local ordinances make up our municipal code. Municipal governments can pass ordinances on matters that the state government allows to be regulated at the local level. The ordinance carries the state's authority and has the same effect as state statute. Local codes can be more restrictive than state code but not less.

Many ordinances deal with maintaining public safety, health, morals, and general welfare. Other ordinances deal with fire and safety regulations that residential, commercial, and industrial property owners must follow. There are also ordinances that deal with public streets, sidewalks and municipal utilities. One of the most significant areas of municipal law is zoning. Zoning ordinances constitute a master plan for land use within our municipality. The village is divided into residential, commercial, and industrial zoning districts. Zoning code purpose is to conserve the value of property and to encourage the most appropriate use of land throughout our Village.

Before an ordinance becomes part of the code, it must go through several procedural steps prior to being voted on for adoption by the Village Board. One of the most important steps is a public hearing. This step allows residents the opportunity to ask questions, raise concerns or endorse the proposed ordinance prior to going before the Village Board for their vote. The village's code of ordinances are routinely reviewed and proposed changes occasionally occur. New ordinances have also been enacted over the past several years. One such new ordinance that has been adopted is ORDINANCE 262-28 which is an ordinance amending the Municipal Code as it relates to sanitary sewer private laterals in the Village of Lena. Recently property owners along West Maple Street received a letter from the village notifying them of the planned street and utility reconstruction project slated to take place along this corridor. The letter referenced the ordinance as it pertains to the private sewer laterals that are in poor condition and the authority of the Village to enforce the ordinance to have those private laterals improved by the property owner during the street reconstruction project.

The intent behind this ordinance is to eliminate the unwanted flow of clearwater into the sewer collection system that enters the system via the in adequately functioning private laterals. The addition of this unwanted clearwater has a huge impact on the overall operating costs of the wastewater treatment plant by having to treat clean groundwater. The additional costs are then ultimately left for all the end-users of the wastewater treatment plant to cover those additional costs via user rates. This is a good example of how an ordinance serves as a positive for all our residents of our community. Ordinance 134-3. Regulation of length of lawn and grasses.

(B) The Village Board finds that lawns, grasses and noxious weeds on lots or parcels of land which exceed eight (8) inches in length adversely affect the health and safety of the public in that they tend to emit pollen and other discomforting bits of plants, constitute a fire hazard and a safety hazard in that debris can be hidden in the grass, interfere with the public convenience and adversely affect property values of other land within the Village..... (G) (2) Failure to comply: the Village shall cut or cause to cut all grass and weeds from the property and shall charge the expense of so doing at a rate established by resolution by the Village Board. This includes trimming around buildings, trees, curbs, etc. Please do NOT blow your grass cuttings into the street. It plugs the storm sewers!






