***The City of Oconto Falls maintains a Curbside pickup route for single stream recyclables.** City residents can also take these recyclables to the City drop off center as single stream recyclables in the recycling roll off containers.

To save on recycling costs to your municipality, please take recyclables to your municipal drop-off center where you reside. Non-residents may be subject to additional charges to dispose of recyclables or not accepted at the drop off center.

The following municipalities manage the recycling for their citizens separately and are not affiliated with the Oconto County Recycling Program: Breed, Brazeau, Chase, Gillett (City & Town), Lakewood, Little River, Mountain, City of Oconto, Pensaukee, Spruce, Townsend, and Underhill.

Businesses are to provide for recycling through their contracted waste hauler. The municipal drop off centers are provided for the residential waste stream.

Recycle plastic bags, film & wrap at participating locations such as grocery, retail & hardware stores. Drop off centers do not accept plastic bags, film or wrap. Loose plastics, rope, hoses & clothing clogs up processing equipment causing unnecessary expenses at recycling facilities.



Don't rely on the Recycling Number on Plastics.“What does each number mean on a plastic container? Do we recycle only #1 and #2 plastics? The numbers called “resin identification codes” only identify the type of plastic resin the product was made from. The numbers don't necessarily mean that the plastic is recyclable. The resin code simply allows recycling plants to classify plastics to help know how to process the materials. The good news is that there is already a change in product labeling to make recycling more user-friendly. **How2Recycle** labeling has been developed to better explain if an item can or cannot be recycled, when to check with local recycler and when to take items to a retail store or drop-off site and how to prep the item for recycling.

Accepted at most drop-off centers: Used Tires, Electronics, Fluorescent & other bulbs (consult with attendant)

Electronics (TV's, PC's, Printers, Fax machines, DVD, VCR)

Properly recycle electronics to protect citizens and the environment. Businesses, agencies and institutions are not included in the household recycling program and are to manage their own waste.

Vehicle tires are accepted for disposal. Fee is based on type of tire noted below:



Vehicle (passenger & light truck) & garden tires

-Passenger Tires	\$4.00
-SUV & Light Truck Tires	\$6.00
-Garden/Mower/Go-Kart Tires	\$4.00
- Pneumatic tires (wheel barrow, hand truck, dolly wheels, etc.)	\$10.00

*Large truck tires

- Light Commercial (46-79lbs)	\$11.00
- Large Truck (80-95 lbs)	\$25.00
- Super Single/duplex (95-130 lbs)	\$28.00

*Agricultural or OTR Tires

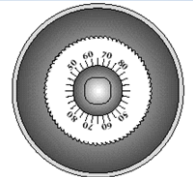

Mercury Thermostats are accepted free of charge at the Oconto County MRF call 920-834-6827 to schedule dropoff. Broken thermostats are not accepted. Only wall mount thermostats with glass tube mercury switches are accepted. Please recycle the entire thermostat. SAVE THE DATE!! Oconto & Marinette Counties are hosting an **Agriculture & Household Hazardous Materials Clean Sweep Event** on May 10th & 11th, 2024. Bring your old and unwanted pesticides, herbicides, poisons, lead & oil based paints, spray paint, stains & varnish, solvents, old gas, automotive fluids, toxic cleaners, degreasers, mercury, and other unknown chemicals to dispose of properly for free!! **Hazardous Business Materials** will be accepted from businesses identified as Very Small Quantity Generators (VSQG) and located within the participating County. Businesses **must pay** for their disposal costs, but may avoid on-site pickup fees. Eligible businesses may receive a 50% subsidy for disposal of pesticide wastes.

2024 OCONTO COUNTY RECYCLING GUIDE

- ✓ **SINGLE STREAM RECYCLING INCLUDES PAPER, CARDBOARD, PLASTIC BOTTLES & PLASTIC CONTAINERS, METAL & GLASS CONTAINERS RECYCLED TOGETHER IN YOUR MUNICIPAL DROP OFF CENTER RECYCLING DUMPSTER.**
- ✓ **If you are in doubt, toss it out!! Do not “wish” recycle an item if you are unsure if it can be recycled. Many consumer products may appear to be of value for recycling and you may wish it could be recycled and then toss the item in the single stream recycling bin without thinking. Not all products are easily recyclable and these items can increase the processing cost to recycle. View brochure for new recycling labeling found on certain products. - ✓ **Garbage/trash, oil, e-waste, scrap metal, used tires, batteries etc must remain separated from single stream recyclables & disposed of properly. Plastic bags, wrap & film can also be recycled just not with the single stream items. See back page for proper recycling and why bags, ropes, etc are detrimental to single stream recycling.**

Plastics-Accept

- Household Bottles, jars & jugs
- Dairy Containers & Lids
- Produce, bakery, & deli containers & Lids

Do Not Accept

- Plastic Bags, Wrap or Film (*take back to store drop off collection sites*)
- Motor Oil Bottles or Jugs
- Styrofoam

Empty, rinse & replace caps and lids.



Paper & Cardboard-Accept

- Newspapers, inserts, magazines, books & mail
- Cardboard (flattened) & Paperboard (food boxes)
- Office paper, school paper & books
- Milk, Juice & Soup Cartons

Do Not Accept

- Pet food bags
- Tissue Paper
- Paper Cups
- Shredded paper (*take confidential papers to shred events for shredding & recycling or consult with shredding service companies*)

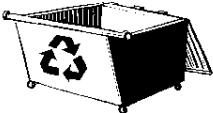


Metal- Accept

- Aluminum Bottles & Cans
 - Steel & Tin Cans
- Empty and rinse*

Do Not Accept

- Aerosol Cans
- Aluminum Pans or Foil
- Empty Paint Cans
- Scrap Metal, Cookware Items
- Propane tanks & cylinders



Glass-Accept

- Food & Beverage Bottles & Jars
- Empty and rinse*

Do Not Accept

- Window Glass
- Ceramics, China or Drinking Glassware
- Mirrors

MISCELLANEOUS RECYCLABLE ITEMS (CONSULT ATTENDANT FOR ACCEPTABLE DISPOSAL)

OIL FILTERS, ABSORBENTS & ANTIFREEZE: \$1 fee for each 5 gallons of items (price subject to change)

Store in leak proof container. Drop off at designated drop site. Place used engine filters, absorbents (oil rags, floor dry, etc), antifreeze or glycol in designated drums, where available.

USED MOTOR OIL: No charge for disposal. No industrial oil or oil mixed with antifreeze, gas, grease or water.



BATTERIES (lead acid): Vehicular batteries (lead acid batteries only). Batteries shall have caps on and in good condition.

SCRAP METALS: All scrap metal accepted such as appliances, copper tubing, sheet metal, etc. Bikes with rubber tires removed. Riding lawn mowers with tires attached are charged \$2.00/tire. Air conditioners, refrigerators or any other freon contained appliance are charged a fee. Items not accepted in scrap pile include Plastic vacuum cleaners, fridges/freezers with meat or food spoilage inside, metal pipes with cement, TV's, microwaves, chemical aerosols, insecticides etc. Consult with attendant for current fees and acceptable items.

TIRES: Vehicle tires are accepted. Charges for disposal are based on type, size or by weight. Heavy ply tires such as tractor, skid steer or large equipment tires may not be accepted at your municipal site. Ask attendant for disposal charge and if heavy ply tires are accepted.

RECHARGEABLE BATTERIES RECYCLE AT PARTICIPATING STORES: Drop off your old rechargeable batteries for free at thousands of convenient locations across the U.S., including Home Depot, Lowe's and Staples www.call2recycle.org (For safe disposal, tape ends or place in separate plastic bags as dead or drained rechargeable batteries still contain sufficient charge to potentially start fires when in contact with other metals) Alkaline, Manganese Carbon Zinc batteries (AAA, AA, C, D, 6V & 9V) can be placed in the trash.



REUSABLE ITEMS, DONATIONS: Search websites where reusable items can be donated. Reusable clothes, toys, cookware, books, or computer related items (monitors, keyboards, hard drives, etc). View www.reconnectpartnership.com for further details on recycling computer related items. Donate items to nonprofit organizations such as Goodwill Industries, St. Vincent DePaul, or locally at New Beginnings Store, 228 W. Park St., Gillett WI 54124 · (920) 834-7148. Contact the store to confirm your donated items are acceptable.
